

Ticket Terms and Conditions 2027 – Electric Picnic Festival (“Event”)

These Event Terms and Conditions (“T&Cs”) incorporate applicable third party-promoter, ticket agent and/or venue terms, conditions and/or regulations – you can ask them for a copy of these. Your possession of a ticket constitutes your acceptance of these T&Cs.

“We”, “Us”, “Our” means EP Republic Limited and/or its representatives, employees and sub-contractors.

“Event” means an event held by the Us for which you have bought a ticket and “Venue” means the venue/site where the Event is being held.

GENERAL

1. We reserve the right to implement restrictions/conditions before and during the Event to ensure it is safe. You must comply with any and all instructions given to you by Event staff and stewards and you may be evicted without a refund if you fail to comply.
2. We can refuse entry/evict you (and may take appropriate action to enforce this right) without refund at our discretion including without limitation for reasons of public safety (including for crowd surfing or moshing) or licensing; if you are acting under the influence of alcohol or drugs; any unacceptable behaviour likely to cause damage, nuisance or injury; if you fail to show proof of identity or age; or for any breach of these T&Cs.
3. Tickets are for the Event and any billed artists and attractions may be subject to change. Published performance times should be treated as a guide only. We and the artist reserve the right to vary the time or duration of any individual set, performance, or activity at any time without notice. This could be for any reason, including (but not limited to) the following:
 - a) logistical constraints: technical issues, delays, or equipment changes may require a performance to be shortened to maintain the overall Event schedule.
 - b) performer discretion: an artist may, at their own discretion, alter the length of their set.
 - c) regulatory or safety reasons: local curfews, licensing restrictions, or safety concerns may require the Event to adhere to a strict finish time, impacting later performances.
 - d) events beyond Our reasonable control, such as severe weather or other emergencies, may affect performance lengths.
4. No trading or promotional activity is allowed within the site without Our prior written consent. Goods using unauthorised logos must be surrendered to Event staff.
5. By attending this Event, you and other attendees understand and agree to being photographed, filmed and/or recorded in relation to the Event and/or for safety and security, including filming by An Garda Síochána. You and other attendees understand and agree that resulting photographs, videos, audio recordings and/or audiovisual recordings may be used in any and all media for any purpose at any time throughout the world (however, you may object to such use by specific request to privacy@livenation.co.uk)
6. These T&Cs are subject to change from time to time in our sole discretion and We will notify you by posting the amended T&Cs to the Event website.
7. We shall have no liability for any loss, injury, illness or damage to any person or property sustained at the Event howsoever caused (including by Us and Our agents) in any circumstances unless caused as a direct result of Our negligence and that which cannot by law be excluded or limited. Any personal property brought to the Event is at your own risk.
8. These T&Cs are governed by Irish Law and any dispute arising out of or in connection with these T&Cs shall be subject to the exclusive jurisdiction of the Irish courts.

REFUNDS

9. Refunds are only considered if the Event is (i) cancelled in full and not rescheduled (if the Event is partially cancelled your refund will be a proportionate partial refund) or (ii) materially altered which is a change (other than a rescheduling) which, in Our opinion, makes the Event materially different to the Event that ticket purchasers, taken generally, could reasonably expect. The following are not deemed to be ‘material alterations’: changes to the Event line-up; adverse weather conditions; changes to individual band members; curtailment of the Event where the majority of the Event is performed; and delays to starting a performance or the Event.
10. Refunds must be requested from the point of purchase, no later than three months after the Event.
11. Refunds of any booking fees per ticket or per order fees are subject to the terms and conditions of the point of sale.
12. Personal arrangements relating to the Event including, but not limited to, travel, subsistence and accommodation are at your own risk and We shall not be liable for any losses incurred from personal arrangements or wasted expenditure beyond the ticket refund.

AGE POLICY

13. You must be 18 years or over to attend this event, with the exception of children aged 12 years and under. Children aged 13–17 years old are not permitted to attend the event even when accompanied by an adult. It is not acceptable to turn up to the festival with children aged between 13-17 and anyone who is of this age will not gain admission to the festival.
14. Children aged 12 years and under must be accompanied at all times by a ticket holding adult, limited to a maximum of two children per adult.
15. We do not act in any parental or supervisory capacity for under 18s on site. This does not affect our legal duties to any attendee in respect of, or obligation to comply with, any applicable laws including health and safety or licensing laws. To provide and ensure a safe festival for you and your children, children aged 12 or under attending the festival can be registered before coming to the festival on the Electric Picnic website. This will enable the Event Organisers to contact Parents / Guardians.
16. Those wishing to stay in the Family Campsite must be accompanied by children aged 12 years and under.
17. Under 18’s are not permitted to bring alcohol or purchase alcohol on site. A Challenge 21 Policy will be in place for all alcohol sales on site. It is illegal for an over 18 to purchase on behalf of under 18s.
18. Proof of age is required to gain entry to the event. Tickets will be deemed void when not accompanied by an acceptable proof of age. Acceptable forms of ID are: Passport, Garda Age Card, Driving Licence.

TICKETS AND WRISTBANDS

19. Tickets must be produced and scanned in order for you to receive a wristband on first entry via a wristband exchange.
20. Tickets must be valid, presented in full according to the authorised agents delivery methods and not altered or tampered with.
21. Tickets purchased from unauthorised sources may be rendered invalid and admission refused. Only wristbands issued by the Event in exchange for a valid ticket are valid for entry. The ticket holder is responsible for their ticket until it is exchanged for a wristband and is then responsible for their wristband for the duration of the Event.
22. Tickets for this event are digital and utilise a secure system provided by Ticketmaster, which includes moving barcodes to prevent ticket fraud and touting. Any attempt to duplicate or resell tickets fraudulently may result in prosecution.
23. Tickets and wristbands remain Our property until the Event closes and are a personal revocable licence which may be withdrawn and admission refused at any time.
24. We will not issue duplicates for lost or stolen tickets or wristbands.

25. Tickets cannot be used as part of any marketing, media or sales promotion, without Our prior written consent.
26. If you have obtained your ticket in breach of these T&Cs and/or if you breach any of these T&Cs then your ticket shall be void, and all rights conferred on you or evidenced by such ticket shall be void. If you seek to gain entry to the Event using a void ticket then we reserve the right to refuse you entry to or evict you from the Event and you may be liable for trespass. Void tickets are non-refundable.
27. Wristbands are strictly non-transferable and will be invalid if removed, tampered with, transferred or resold. Wristbands must be worn at all times for the duration of the Event.
28. Ticket resale is not allowed except through the official Ticketmaster Ticket Resale in accordance with its resale platform Terms and Conditions.
29. As a Designated Event under section 9(1) of the Sale of Tickets (Cultural, Entertainment, Recreational and Sporting Events) Act 2021, it is unlawful to resell tickets for the Event for more than the face-value or to purchase tickets in excess of the maximum ticket limits set at the point of purchase.
30. There is strictly no readmission on day tickets or wristbands. Readmission is only permitted on weekend wristbands.
31. Day ticket holders may only leave and re-enter the venue during the Event at our discretion and/or that of the venue management.
32. Anyone attempting to enter on false accreditation or by misrepresentation will be refused entry, may have their accreditation confiscated and may be reported to An Garda Síochána.

SECURITY

33. Searching is a condition of entry, and you may be searched anywhere on site at any time by security.
34. Without liability to you, we shall be entitled to confiscate any item(s) which may reasonably be considered to be a weapon (or used as a weapon) or which may cause danger, offence or disruption to any other person.
35. Any person suspected of carrying illegal items or carrying out illegal activity may be handed over to An Garda Síochána and refused entry.
36. Electric Picnic has a zero tolerance policy to drugs. Anyone found in possession of illegal drugs or substances may be refused entry or ejected from site and may be handed over to An Garda Síochána.
37. We reserve the right to evict attendees without refund, and/or refuse admission where the Eviction Policy is breached. Anti-social behaviour may lead to eviction, please act responsibly. See **Eviction Policy** on the website.
38. You may be body/bag searched anywhere on site at any time by security. Searching is a condition of entry.
39. Any item(s), reasonably considered to be a weapon (or used as a weapon), which may cause danger, offence or disruption to any other person will be confiscated.

DAMAGE/LOSSES

40. We do not accept any liability for personal or property damages, losses (including surrendered items) or injuries sustained at this Event - other than caused as result of Our negligence. Attendance at this Event is at your own risk.
41. We may prosecute you if you cause damage to the site, the site infrastructure, or cause harm to any other person at the Event and/or site.

BANNED ITEMS

42. **Banned from Event** – Smoke and gas canisters (except those fitted in campervans), aerosols over 250ml, airhorns, fireworks, flares, blow torches, flag poles, glass, illegal and/or unidentifiable substances, drugs, 'legal highs' – this includes Nitrous Oxide and associated equipment including balloons, new psychoactive substances (NPS), fires, items which may be regarded as weapons, illegal items, laser equipment/pens, megaphones, skateboards, scooters, hoverboards or any personal motorised vehicles, bicycles (must be stored in the bike facilities provided), sky lanterns & kites, petrol burners, large sound systems, candles & incense, spray cans, tabards/hi vis jackets, animals (except guide/hearing dogs), professional radios / walkie-talkies, unauthorised vehicles, goods for unauthorised trading & goods with unauthorised logos, generators (except for diesel generators fitted in campervans)
43. Gazebos are permitted in the campsites but limited to a maximum size of 6mx3m.
44. Single use or disposable vapes are not permitted on site and will be confiscated if found at entry gates and arena entrances.
45. Alcohol for personal consumption of either 48 cans, 1 litre of spirits or 1.5 litres of wine. Please note that alcohol must be contained in plastic bottles as glass is not permitted.
46. No excessive amounts of food and cigarettes - only a reasonable amount for personal consumption is permitted.
47. If you need to bring specific food or drink or medication due to a pre-existing medical condition, please bring supporting medical evidence and the items in their original packaging.
48. The use of drones (including toy drones) or similar is prohibited on or near the Event.
49. No unauthorised vehicles will be allowed on site.
50. **Banned from Arena** – Bags bigger than A4, alcohol, camping equipment, disposable barbeques & campsite stoves, umbrellas, video / audio recorders, gazebos / canopies, large or open drinks (PERMITTED items include - under 500ml sealed* plastic soft drinks/water bottles and empty reusable bottles of any size.)
51. Photographic and other recording equipment is permitted if it is for personal non-commercial use only. We may confiscate and/or destroy any unauthorised recordings or professional recording equipment. We reserve the right to charge a licence fee for any commercial use of photographs / visual / audio recordings taken at the Event.
52. Items that are surrendered or confiscated will not be returned. Anyone resisting the surrender of banned items or disregarding these conditions will face eviction.

HEALTH AND SAFETY

53. Fires and the burning of any materials is not permitted anywhere on the Event site. Anyone involved with starting a fire or throwing anything onto a fire will be evicted from site.
54. Smoking (including e-cigarettes and/or vaping) is not permitted in enclosed public spaces or buildings including arena big tops.
55. Excessive exposure to loud music may cause damage to your hearing.
56. Pyrotechnics, lasers, smoke machines, strobe lighting/special effects may take place during some performances.
57. All those attending the Event do so at their own risk.
58. The use of cooking stoves are only permitted in designated BBQ areas. Gas & Disposable BBQ's are not permitted.
59. Sleeping in vehicles or camping in the car parks is not permitted.
60. No animals, other than guide or hearing dogs, are permitted on site.
